We provide a commercial waste and recycling service across the Lancaster district. Commercial waste is subject to specific disposal requirements for which a charge applies.

- Six day collection where viable
- Evening collection services available in Lancaster city centre only
- Flexible billing arrangements
- No charge is levied for the 'duty of care' documentation
- Full range of Eurobin containers at very competitive rates
- Friendly, efficient staff who deal with all aspects of trade refuse



#### **Eurobin features and benefits**

A Eurobin container means rubbish does not need to be left on the floor which creates a better impression for your customers. Most containers have a close fitting hinged lid that can be securely locked to keep smells in and vermin and arsonists out. Containers are easy to manoeuvre and load by hand - the containers have a low loading height and a drainage plug to enable ease of cleaning.



Trade sacks and labels are available in multiples of 50 for smaller businesses or those with limited space. They can be purchased at:



- Visitor Information Centres in Lancaster or Morecambe (cash, cheque or credit/debit card)
- Environmental Services Depot at White Lund (cheque or credit/debit card)
- Customer Service Centres at Lancaster or Morecambe Town Hall (cheque or credit/debit card)
- Alternatively you can place an order for delivery by telephoning 01524 582415/ 582416. A delivery
  charge applies where an order of only 50 of either type is made. For orders of over 50 there is no
  delivery charge.

### **Duty of Care**

All businesses have an obligation to ensure that all reasonable steps are taken to store and dispose of waste, including using a waste collector who is a 'registered carrier' of waste. Lancaster City Council's Environmental Services is a licensed waste carrier and will take care of your needs efficiently.
